PARK AND MEMBERSHIP GUIDELINES

1. Minors must have their parent or legal guardian **sign this waiver form in person** at the Skate Park office or **have this form notarized. ABSOLUTELY NO EXCEPTIONS!**
2. This Skate Park membership is **valid for 1 (one) year** from the application date.
3. Members **must present their valid membership I.D. card each time they register** for use of the Skate Park. Members **without their valid I.D. card** or record of membership may be required to fill out a day use waiver complete with the proper parent or guardian signatures (if under 18 years of age) and pay non-member fees.
4. Participants with **expired memberships** will be required to **renew their membership** or **pay non-member fees**.
5. Skating/riding is restricted to the **Skate Park only**. Skating/riding outside the park may result in suspension of Skate Park privileges.
6. All participants **under 18 years of age** are required to wear a **helmet with a strap, elbow pads, and knee pads** at all times.
7. Participants **18 years of age or older** are **required to wear a helmet** with a strap. **Elbow pads and knee pads are optional** but are highly recommended.
8. Parents and spectators are to remain outside the park gates at all times.
9. Food and drinks are to be kept in designated areas only. **No glass allowed in the park**. Please throw away your trash in the proper receptacles. **Smoking is prohibited on all YMCA property**.
10. The YMCA is not responsible for lost or stolen articles. **Do not leave items unattended**.
11. Be observant of the skaters/riders around you at all times. Please respect your fellow skaters/riders and park staff.
